In response, Mid-Ohio Foodbank provided food to 524,300 hungry neighbors over the last year. Since 1980 we've worked with food pantries, soup kitchen, shelters, after-school programs, and senior housing sites across central and eastern ohio to feed our hungry neighbors. In the past year, Mid-Ohio Foodbank distributed 69.1 million pounds of food and grocery products, more than half of which was fresh foods that families need for a healthy life. Each day this enables our 650 partner charities to provide 154,518 meals to families, seniors, and individuals trying to make ends meet.
